

## FAQs for the Winter EOC 2020 Main Administration Extension

December 18, 2020

### What are the dates for the Winter EOC 2020 Main Administration extension?

The Winter EOC 2020 Main Administration window has been extended to Friday, January 22, 2021. This extension provides additional flexibility for districts needing time to complete winter EOC assessments because of late start dates for the school year, school closures, and required quarantines.

### Will there be a January EOC 2021 Mid-Month Administration?

No. The January EOC 2021 Mid-Month Administration has been removed and replaced with a longer window for the Winter EOC 2020 Main Administration.

### What should be done for students who were not able to complete their test sections due to school closures or required quarantines?

Students who have not completed all sections can complete the remaining sections until the close of the window on Friday, January 22, 2021. Students will not be required to retake the earlier section if the section is completed during the extended Winter EOC 2020 administration window.

### Will students be allowed to retest during this extension?

No. The Winter EOC 2020 Main Administration is intended for students completing courses and not for those requiring a retest from a previous administration. Please see the *Student Assessment Handbook* (p. 63). Students needing a retest opportunity may participate in the February 2021 Mid-Month Administration, Monday, February 8, 2021 – Friday, February 19, 2021.

### What will districts need to do if students and test sessions are already loaded in the Spring EOC 2021 Mid-Month for use during the January EOC 2021 Mid-Month?

Students in Spring EOC 2021 Mid-Month test sessions will be moved by DRC to the Winter EOC 2020 Main Administration. Any accommodations previously assigned by the district will not be moved. Districts will need to add accommodations for their students prior to testing. Any **printed** test tickets originally intended for the Spring EOC 2021 Mid-Month (January) will need to be destroyed and **new** test tickets printed.

### When will districts be able to set up test sessions for Spring EOC 2021 Mid-Months?

The new test set up window for Spring EOC 2021 Mid-Months will open Monday, January 18, 2021 and close Friday, March 26, 2021. This test set up window is intended for students participating in the February and March EOC 2021 Mid-Months.

### When will reports be delivered for the Winter EOC 2020 Main Administration?

Preliminary reports will begin posting around Wednesday, December 30, 2020 and will continue posting as student score results become available. The anticipated posting date for final reports will be available in mid to late February 2021. Additional notifications regarding the posting of final student results will be sent to System Test Coordinators (STCs).
