

Only GaPBIS and RESA trained PBIS schools located in active PBIS LEA's may submit data. An active LEA has a PBIS district leadership team (DLT) that partners with a GaPBIS Technical Assistant and RESA School Climate Specialist to implement a multi-tiered social, emotional, and behavioral system of support and practices, and has a PBIS District Coordinator (DC) to assist with the fidelity of implementation (.5 FTE/10 PBIS schools is recommended).

### PBIS Assessment Guidance

**Participation in PBIS Assessment by the school and the PBIS District Coordinator is mandatory. All Self-Assessment Survey (SAS) and Tiered Fidelity Inventory (TFI) scores must be in PBIS Assessment ([www.pbisapps.org](http://www.pbisapps.org)) by May 13, 2022 to be considered. A qualified TFI score is one that is greater than 0. If schools score multiple tiers on the TFI, all scores should be entered in PBIS Assessment simultaneously to accurately represent the work of the PBIS team. For example, if Tier I was taken May 4 and Tier II was taken May 6, both scores should be entered May 6 at the same time.**

### Outcome Data Requirements

**Emerging** – Schools must meet **2 of 4** outcome data measures (excluding Corporal Punishment, Persistently Dangerous).

**Operational** – Schools must meet **4 of 4** outcome data measures (excluding Corporal Punishment, Persistently Dangerous).

**Distinguished** – School must meet **ALL 6** outcome data measures.

### Key Data Elements Used for Determining Recognition Levels

**State Reportable<sup>1</sup> Office Discipline Referrals (ODRs):** ODR rates are calculated per 100 students in order to compare across school years  $[(\text{total ODRs})/(\text{total students}) \times 100]$ . State reportable ODRs count the number of students involved in state reportable incidents.

**In-School Suspension (ISS) Days:** Suspension rates are calculated per 100 students in order to compare across school years  $[(\text{total days of ISS})/(\text{total students}) \times 100]$ .

**Out of School Suspension (OSS) Days:** Suspension rates are calculated per 100 students in order to compare across school years  $[(\text{total days of OSS})/(\text{total students}) \times 100]$ .

**Percentage Change:** Percentage change will compare ODR, ISS, and OSS data from three (3) years ago to the current year (2018-2019 to 2021-2022).

**Highest/Lowest Quartile (highest/lowest 25%):** These calculations will include all schools within the state (not only PBIS schools).

**Grade Band and Program Classification:** Elementary, middle, high, GNETS and alternative schools/programs will be considered separately when calculating quartile rates. Schools with multiple grade bands will be classified based on the school's grade band with the highest enrollment.

### Recognition

GaPBIS recognizes schools at four (4) levels, as described in the PBIS Recognition Criteria chart below. Schools are only eligible for Installing recognition in the initial training year. Training year is defined by July 1 - June 30. Although there are exceptions, schools will typically need three (3) to five (5) years to complete training and implementation.

All recognized schools will be listed on the GaPBIS webpage with five (5) bonus points<sup>2</sup> (if applicable) recommended for School Climate Star Rating. Emerging, Operational and Distinguished schools will receive certificates of recognition from the GaDOE. In addition, Operational and Distinguished schools will receive a letter of recognition from the State Superintendent to the LEA Superintendent.

<sup>2</sup> PBIS schools will not receive the additional five (5) points on the School Climate Star Rating if the student and personnel surveys do not meet the 75% participation requirement.

<sup>4</sup> A neutral observer trained in PBIS should conduct a school walkthrough and provide coaching at TFI meetings. Examples of a neutral observer consist of the following: a DC, a PBIS coach from another school either in or out of district, a RESA-based School Climate Specialist, a person under contract by the GaDOE PBIS team or a member of the GaDOE PBIS team. TFI walkthroughs and/or meetings should include a neutral observer as part of best practices and is strongly recommended.

Additional consideration may be given for the PBIS Team's majority participation in any training and/or program that positively impacts school climate. Examples include RESA-approved Mental Health Awareness Trainings (MHAT), Sources of Strength, or Trauma-Sensitive Schools. Schools may also submit a description of any other training and/or program for consideration. A description of the training should include length of training, number of PBIS school team members trained and applicable action steps.
